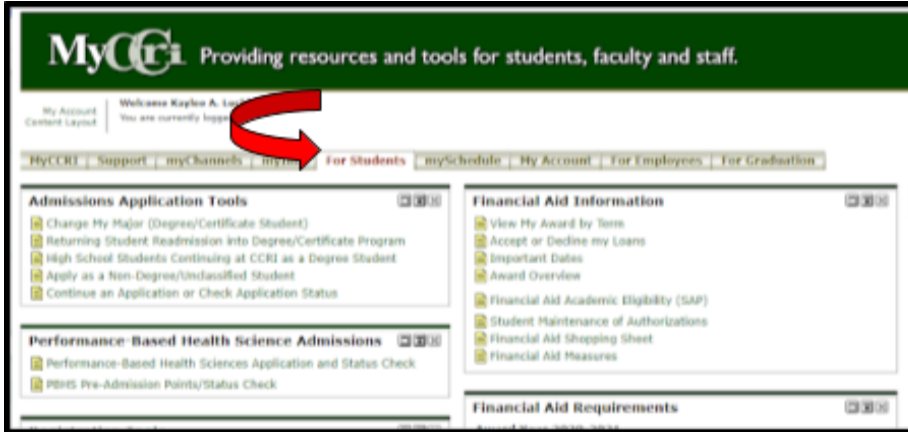


# How do I submit additional documents for my financial aid?

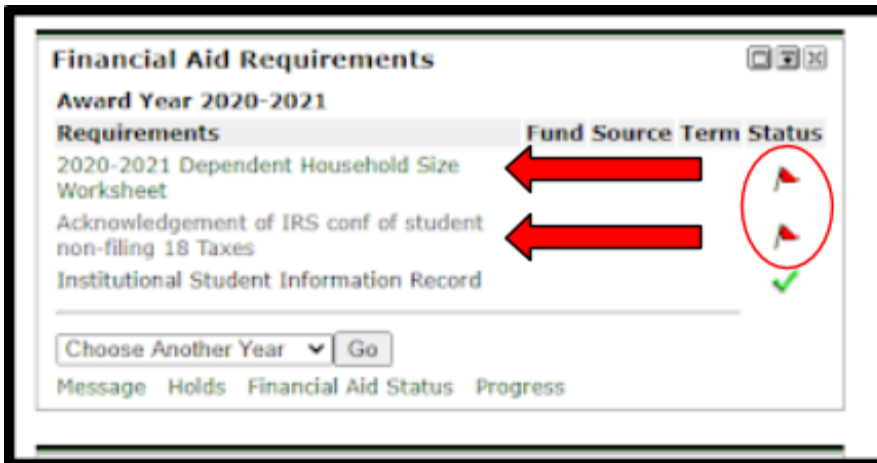
1. Log in to your MyCCRI account
2. Click on the “For Students” tab




3. Scroll to the “Financial Aid Requirements” box

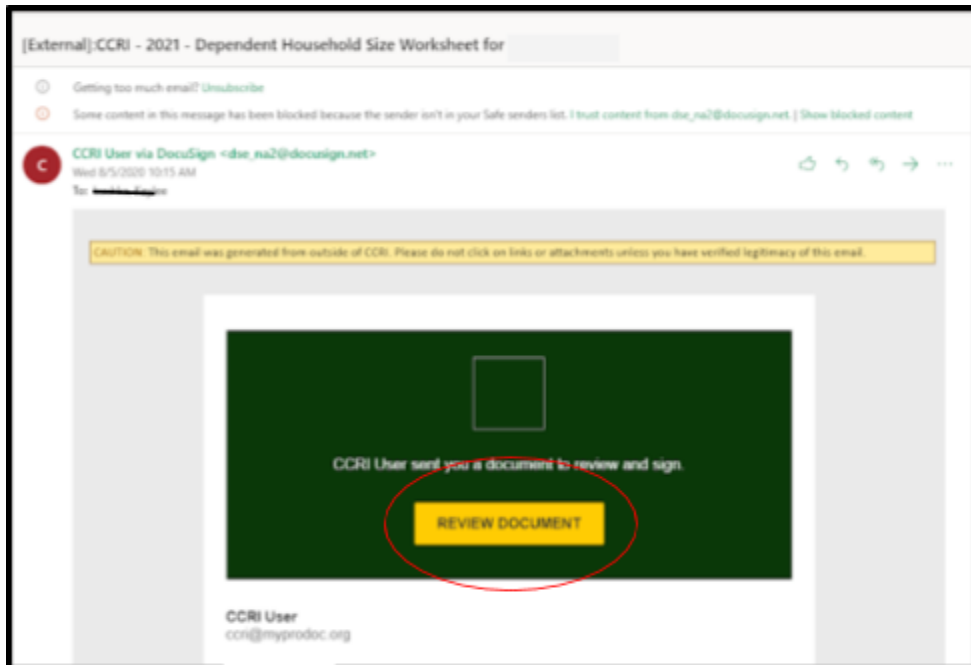
